



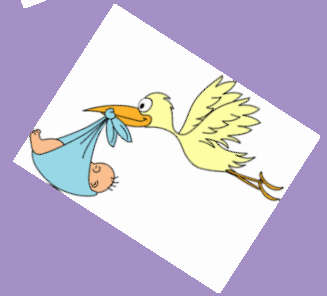

ADDING/DROPPING FAMILY MEMBERS - IMPORTANT!

You Have 30 Days to Notify Employee Benefits of a Family Status Change such as a birth, adoption, marriage, divorce, domestic partner eligibility or loss of other coverage. Notify Employee Benefits staff by completing a new Health Plan Enrollment/Change Form found on the Marion County website by going to: Business Services then Employee Benefits. Pick the appropriate link to locate your form.

It is extremely important you notify Employee Benefits staff within 30 days of the date of the event. If you don't, you will have to wait until the next open enrollment period to make the change.

REMINDERS & LITTLE KNOWN FACTS:

* You may cover your child until age 26, regardless of their marital status or place of residence. Their coverage remains in place until the end of the month in which they turn 26. They are eligible for COBRA at that time.

* PacificSource offers a "hospital-based class reimbursement" to each of their covered members. Each person covered can receive reimbursement up to \$150 per plan year for a variety of classes such as CPR, parenting, nutrition and more. See PacificSource.com/extras for more information
