<b>Compensatory Time Cap</b>	75 hours
<b>Most Recent Pay Increase</b>	7/1/24: 4% COLA
<b>Next Pay Increase</b>	7/1/25: 3% COLA
<b>Bilingual Pay</b>	5% upon passing test and only if position requires it
<b>457 (Deferred Comp)</b>	No County contribution
<b>PERS IAP</b>	County pays 6% County pays employee contribution

<b>Medical/Dental 2024 Plan Year</b>	County pays monthly premiums up to \$2,150 cap.  Cost to employee is \$0.00.  Health Savings Account participants receive a pro-rated County contribution amount.
<b>Basic Life Premium (Fully paid by County)</b>	All regular employees with a minimum of 0.5 FTE \$0.11 per \$1,000 of annual earnings
<b>AD&amp;D Premium (Fully paid by County)</b>	All regular employees with a minimum of 0.5 FTE \$0.042 per \$1,000 of annual earnings
<b>Long Term Disability Premium (Fully paid by County)</b>	All regular employees with a minimum of 0.5 FTE \$0.38 per \$100 of monthly covered payroll
<b>Wellness (Fully paid by County)</b>	\$3.30 per month
<b>EAP (Fully paid by County)</b>	\$3.10 per month
<b>401K</b>	Not Eligible
