REGULATORY UPDATES Temperature TMDL

Proposed rules for the Willamette Temperature TMDL replacement were submitted to the EPA, with a decision expected by September 15, 2024. The Willamette Subbasins' Temperature TMDL rules were adopted by EQC,

pending EPA action.

The Willamette River mainstem and major tributaries are tentatively

scheduled for submission to the EPA on February 28th, 2025.

TMDL for New Pollutants

No new information.

MS4 Phase II Renewal

The DEQ is finalizing language for the post-construction component of the MS4 Phase II permit. Expected to release draft language by year-end.

CSRC MANAGEMENT STRATEGY

Construction Site Runoff Control Discussion

Options for erosion and sediment control Mercury TMDL requirement were reviewed. Staff discussed potential incorporation of requirements into building permits and educational materials.

The committee deferred final action to allow more time for further information and feedback from stakeholders, especially the Home Builders Association.

STAFF UPDATES

Annual Reports

Staff is compiling annual reports for MS4 Phase II and TMDL programs, due in November. Prior reports are available on the county website.

Certification Prep Classes

OSU Extension will offer in-person laws and safety classes for pesticide licensing in February 2025.

Operations Projects

Staff reported on the next phase of the East Salem drainage ditch restoration project, set to begin in the coming weeks between Silverton Road and Sandringham. Staff noted efforts to streamline permitting by consolidating approvals for the entire project area, which will reduce processing time and costs.

Additional projects included recent dredging efforts at ferry paths. Staff also noted an upcoming culvert replacement in Woodburn which will improve fish passage.

Membership

The committee welcomed prospective members in attendance and noted ongoing efforts to fill vacant seats. Interviews will be scheduled as part of the membership review process, with formal approval pending from the Board of Commissioners.

Committee members provided feedback on the current Chair's role and expressed appreciation for effective leadership.

The committee discussed the importance of continued engagement with community stakeholders, especially around key regulatory updates and construction site runoff control. Members agreed that these updates support transparency and ensure alignment with the county's environmental goals.
