

PETITION FOR THE IMPROVEMENT OF

We hereby petition the above-entitled Board for an order and all other acts and proceedings, for the improvement of that certain public road located in Marion County, Oregon, to-wit:

In support of this petition, we represent and allege:

- (1) That the signers of this petition constitute not less than 60 percent of the owners of property abutting on the proposed improvement; and that their ownership collectively represents not less than 60 percent of the property (acreage or frontage) abutting on the proposed improvement. And;

(2a) _____ That this petition is made pursuant to Oregon Revised Statutes (ORS) 371.605 to 371.660, inclusive; that each owner of property affected by the proposed improvement agrees to comply with and be bound by all provisions, terms, and conditions of these statutes, that each owner consents to the assessment against his or her respective property and ownership, subject to the right to make timely objections to such assessment as may be fixed by the Director of Public Works; and that after final determination of the amount of such assessment against each parcel of property and certification thereof to the County Clerk, does agree that each assessment shall be a valid and enforceable lien against the representative properties whether or not the applicable statutes are hereafter held invalid in whole or in part, by any Court, or whether same be repealed by subsequent act of the State Legislature. **It is understood by all signers of this petition that this option results in the County acceptance of the improved roadway into the County road maintenance network.**

(2b) _____ That this petition respectfully requests the County Board of Commissioners as the County governing body exercise the authorities granted to them under ORS 368.031, ORS 223.387 to 223.401, inclusive, and ORS 223.205 to 223.295, inclusive (copy attached); that each owner of property affected by the proposed improvement agrees to comply with and be bound by all provisions, terms, and conditions of these statutes, that each owner consents to the assessment against his or her respective property and ownership, subject to the right to make timely objections to such assessment as may be fixed by the Director of Public Works; and that after final determination of the amount of such assessment against each parcel of property and certification thereof to the County Clerk, does agree that each assessment shall be a valid and enforceable lien against the representative properties whether or not the applicable statutes are hereafter held invalid in whole or in part, by any Court, or whether same be repealed by subsequent act of the State Legislature. **It is understood by all signers of this petition that this option does not result in the County acceptance of the improved roadway into the County road maintenance network; maintenance of the road remains the responsibility of the abutting property owners.**

Disclaimer: Signers of this petition are urged to thoroughly understand the importance of this petition before signing. All required information must be filled out completely and accurately, to allow timely processing. The signing of this petition means that, if the improvement is authorized, the work will be done and you will be responsible for your share of the costs. It is in effect a contract. The assessment may be paid in a lump sum after completion of the work or in accordance with an installment payment plan under ORS 223.215.
