NOTICE OF DECISION PARTITION CASE NO.21-020

APPLICATION: Application of Joshua Heneveld to divide a 4.82 acre parcel into two parcels containing 2.0 acres and 2.82 acres each in an AR (Acreage Residential) zone located at 7972 Pudding Creek Dr. SE, Salem. (T8S; R2W; Section 2C; Tax Lot 4100).

DECISION: The Planning Director for Marion County has **APPROVED** the above-described Partition application subject to certain conditions.

EXPIRATION DATE: This approval is valid only when the final partition plat is recorded by **September 17, 2023**. The effective period may be extended for an additional year subject to approval of an extension (form available from the Planning Division). Additional extensions may not be granted if the regulations under which this decision was granted have changed since the original approval.

WARNING: A decision approving the proposed division is for land use purposes only. Due to septic, well, and drain field replacement areas, these parcels may not be able to support a dwelling. To be sure the subject property can accommodate the proposed use the applicant should contact the Building Inspection Division, (503) 588-5147.

This decision does not include approval of a building permit.

<u>CONDITIONS</u>: The following conditions must be met <u>before a building permit can be obtained or the approved use</u> <u>established</u>:

Prior to recording the final plat:

- 1. The applicant shall submit a final partition plat to the County Surveyor's Office (5155 Silverton Road NE; (503) 588-5036) and shall contain the notation that the survey is the result of Partition Case 21-020. Following plat approval it shall be recorded with the Marion County Clerk, checking fee and recording fees required. (Plat instructions enclosed).
- 2. A current or updated title report must be submitted at the time of review. Title reports shall be no more than 15 days old at the time of approval of the plat by the Surveyor's Office, which may require additional updated reports.
- 3. Prior to submitting the final partition plat, the applicant shall obtain an approved septic site evaluation from the Marion County Building Inspection Division on all undeveloped parcels. The applicant is strongly encouraged to contact Building Inspection, (503) 588-5147, regarding septic sites <u>before</u> having the property surveyed. Septic site requirements <u>may</u> affect the proposed property line or lot locations.
- 4. The Marion County Planning Division has addressed the proposed new parcel **7982 Pudding Creek Dr SE**, effective and valid once the final partition plat is recorded.

Prior to issuance of building permits on the resulting parcels,

5. The partition plat shall be recorded.

ADDITIONAL CONDITIONS: Once the approved use is established the following conditions must be continually satisfied:

- 6. The resulting parcels shall significantly conform to the site plan submitted with the proposal. Minor variations are permitted upon review and approval by the Planning Director. All parcels shall be a minimum two acres in size.
- 7. After the final Partition plat has been recorded no alteration of property lines shall be permitted without first obtaining approval from the Planning Director.

OTHER PERMITS, FEES, AND RESTRICTIONS: This approval does not remove or affect covenants or restrictions imposed on the subject property by deed or other instrument. The proposed use may require permits and/or fees from other local, State or Federal agencies. This decision does not take the place of, or relieve the responsibility for, obtaining other permits or satisfying restrictions or conditions. It is recommended that the agencies mentioned in Finding #9, 10 below be contacted to identify restrictions or necessary permits. The applicant is advised of the following:

- 8. Prior to recording the plat all taxes due must be paid to the Marion County Tax Department (contact the Marion County Tax Department at 503-588-5215 for verification of payments).
- 9. The applicants should contact the Marion County Fire District to obtain a copy of the District's Recommended Building Access and Premise Identification regulations and the Marion County Fire Code Applications Guide. Fire District access standards may be more restrictive than County standards. **Paula Smith at MCFD#1 (503) -588-6513 as the contact person).**
- 10. The applicants should contact Marion County Land Development and Engineering (503-584-7714) for additional Engineering Requirements and Advisories, listed in Finding #5 below, that may be required.

APPEAL PROCEDURE: The Marion Zone Code provides that certain applications be considered first by the County Planning Director. If there is any doubt that the application conforms with adopted land use policies and regulations the Director must condition or deny the application. Anyone who disagrees with the Director's decision may request that the application be considered by a Marion County hearings officer after a public hearing. The applicant may also request reconsideration (one time only and a fee of \$200) on the basis of new information subject to signing an extension of the 150 day time limit for review of zoning applications.

A public hearing is held on appeals subject to the appellant paying a \$250.00 fee. Requests for reconsideration, or consideration by a hearings officer, must be in writing (form available from the Planning Division) and received, together with the appeal fee, in the Marion County Planning Division, 5155 Silverton Rd. NE, Salem, by 5:00 p.m. on

September 17, 2021. If you have questions about this decision contact the Planning Division at (503) 588-5038 or at the office. This decision is effective **September 18, 2021** unless further consideration is requested.

FINDINGS AND CONCLUSIONS: Findings and conclusions on which the decision was based are noted below.

- 1. The property is designated Rural Residential in the Marion County Comprehensive Plan. The purpose of this designation and the corresponding AR (Acreage Residential) zone is to allow creation of acreage homesites at a density that maintains the character and environmental quality of rural residential areas.
- 2. The subject parcel is located 0.2 miles west of the intersection of Pudding Creek Dr SE and 82nd Ave SE. The parcel contains a dwelling and an accessory structure that is a barn. The parcel has a permitted dwelling from 1975 and is a lot from the Waldo Hills Park plat and is therefore, considered legal for land use purposes.
- 3. Surrounding uses are residential in all directions, with all parcels being zoned AR and developed with small acreage home sites.
- 4. The applicant proposes to divide a 4.82 acre parcel into two parcels containing 2.0 acres and 2.82 acres each.

5. <u>Public Works Land Development and Engineering Permits</u> (LDEP) requested that the following be included in the land use decision.

ENGINEERING REQUIREMENTS

- A. Access shall be shared; no secondary access will be allowed. At the time of application for building permits, an Access Permit will be required.
- B. Transportation System Development & Parks Charges will be assessed at the time of application for building permits.
- *C.* Utility service extensions within the public right-of-way require utility permitting from PW Engineering.

Marion County Surveyor commented:

- 1. Parcels ten acres and less must be surveyed.
- 2. Per ORS 92.050, plat must be submitted for review.
- 3. Checking fee and recording fees required.
- 4. A current or updated title report must be submitted at the time of review. Title reports shall be no more than 15 days old at the time of approval of the plat by the Surveyor's Office, which may require additional updated reports.

<u>Marion County Fire District No. 1</u> provided comments relating to access, fire flows and other fire code standards. A copy of these conditions is available from staff.

<u>Marion County Septic Inspection</u> commented: "The new parcel will require site evaluation for existing parcel per Marion County Policy and will require a more detailed plot plan showing actual measurements of drain field and measurements from drain field to all property lines and existing lines that could affect drain field and proposed drain lines.

Marion County Building Inspection commented: "No building inspection issues. Permits are required for any proposed development."

Marion County Assessor's Office provided information related to the subject properties property taxes.

Salem-Keizer Public Schools provided comments related to the additional students this would add to the district.

All other contacted agencies either failed to comment or stated no objection to proposal.

- 6. There are no specific approval criteria for partitions in the AR zone. MCC 17.128.070 requires a minimum lot size of two acres and the new parcels are consistent with this standard. Subsequently, the proposal meets the criteria for partitioning in the AR zone.
- 7. Based on the above findings, the proposed partition complies with the applicable criteria and is, therefore **APPROVED.**
