Canterbury Renaissance Faire Public Safety Plan

The 16th annual Canterbury Renaissance Faire- July 18, 19, 25, 26, 2026- 10am to 6pm Saturday and Sunday only. 2 weekends this year.

We will sell our tickets online. With an unadvertised ability to buy tickets at the gate. Our own cap is planned at 5000 Patrons on the Faire site per day. We have yet to achieve that number.

The official address is 6518 Cascade Hwy Silverton. This is the renter's address and the address of the property. However, we are using the address of 6569 Valley View Rd. Silverton (as per Google) to keep the public away from the renter's house on the property. This also allows cars to get off Hwy 213 for access.

Please refer to the site plan provided.

Parking will be in an approximately 9-acre field which is flat and clear with a slight slope. It is in grass seed now and will be harvested, baled, and cleared to the nubbin by July 10th. The parking will be handled by a professional event parking crew. The professional parking crew who did the car parking will be working with us again in 2026. They worked well in 2024 and in 2025. The site map has the parking marked out with the dimensions given by the county parking and traffic control. This plan includes a handicapped parking area close to the entrance closer to the woods. There will be an alley all around the field and through the middle wide enough for cars to pass opposite of each other and for Fire and water truck access.

Last year we had few, if any problems with traffic flow.

This year, parking on the field will again charge \$10. /Car to park.

We will offer **FREE** shuttle parking using the Silverton High and Middle Schools. I also have my 7+ acre flat grass field at 6118 Mt Angel Hwy for extra parking that will be prepared to use for over, overflow parking.

We will have professional parking crews at all locations, and we will run 3 or 4 shuttles with the opportunity to add another bus if necessary. The Shuttle company is:

The shuttle bus will pull off Valley View into a shuttle and Uber drop off only by the entrance separate from the parking cars on the field. Review site map.

The other 3 parking locations will not have access problems on the roads.

This plan will give us approx. 2250 places to park. From 9am-2pm there is the biggest need for parking. After 1 to 2 pm, the patrons will come and go, which will allow for more parking.

The car access will be located off Valley View Rd. There will be no access to the Faire for the public on Hwy 213.

The participant parking will be to the southwest side of the tree grove by the public parking field. See the site map.

Site safety: This will be managed by a group of people called the Queen's Guard. It is made up of people who have previous site safety experience at Canterbury Faire and other Faires as well. The Captain of the Guard is Abigail Whitefahl. She has been with the Faire since its inception and knows the details. Her phone # is 503-572-0297. Her second in command is Kaine MacAoidh. We have 16 experienced people to cover security and safety. Abigail and her group will be on site starting Wednesday July 14 and will stay on site throughout the run of Faire. They will be always patrolling through the night.

During the Faire hours, we are hiring a professional security crew of 2-armed people to patrol the Faire and deal with security problems that might come up with the patrons. We have not had any incidents in the last 14 years. We have never had any security or safety problems to date.

The Joust Show:

The jousting arena (80'x180') has a wood fence to keep people from going into the joust show arena. The people watching will be standing, sitting on wood benches or new wooden bleachers with shade cloth to protect them from the sun. We will have people making sure the visitors will not go near the knights or their horses during the show. The Seattle Knights are a professional troupe with lots of experience. 2026 will be their 7th year performing the Joust Show.

Since it is a family event, we do not anticipate a lot of trouble, nor have we had trouble in the past.

Tavern:

We are offering an ale yard (Oberon'sTavern) which will be contained and monitored for minors, and they have their own security. Please contact Jordan McKay for the details of his Beer and wine area. Contact Jordan McKay at # 541-864-9822. He is based out of Eugene, OR. His OLCC license is not attached but available upon request. Oberon's, Jordan's tavern, has been used in many Fairs throughout the area with no incidents. This is his 15th year with us.

Camping:

Only the participants will be allowed to camp on the grounds. There will be no drugs. There will be no pets loose in the area. And as stated, we have security at night. We encourage all campers to have up to date fire extinguishers at their camp. NO CAMPFIRES will be allowed.

Patron safety:

Since it is a Renaissance Faire, people will wear swords and daggers as that is part of the period garb. All weapons will be inspected and will be peace tied (tied down). The weapons will only be used for appearance's sake. Any visitor who draws any weapon for any reason will be promptly escorted from the Faire.

Smoking:

We have tried to have a no smoking event; however, we learned that people will smoke. So, to that end, we are providing onsite containers. They can smoke out of sight and in private. We have 2 smoking areas, both in the camping area. We will have sand containers for the butts. The ground will be cleared to dirt. 2 places will be provided on the Faire site apart from each other.

Medical and First Aid:

The medical and emergency will be run by the Scotts Mills Fireman's Assoc. during Faire hours. They have all of the equipment, personnel, and contacts needed. There will be 2 people for first aid on site during the hours of the Faire and after hours we have 2 adults designated to be available for first aid for the participants. We are offering free cups of water at the first aid booth and selling bottled water during the Faire hours. We also have 2 - 55 gallons water barrels that are connected to 550 gallon tanks providing free water filled with trucked in, potable water. The Silverton hospital is a few miles from the Faire grounds, and the ambulance has clear access to the Faire area.

Fire safety:

The Silverton Fire Dept. ALWAYS has free access to the Faire site and does an inspection of the grounds for access and fire safety compliance. They will be on site inspecting the food vendors for safety. I send to all the vendors the State Fire Marshall guidelines for this kind of activity. All vendors must have an up-to-date fire extinguisher in their booths.

Sanitation: We are offering 60 portable standard unit potties and 8 handicapped units. We have a wash basin at all the unit groupings on site. Approx. 10 wash basins. We have a standing agreement with the portable toilet company to bring in more potties if needed. They will be cleaned daily. There is also a wastewater basin located at the food court as well.

For garbage waste, we have 2 large dumpsters That will be emptied after each weekend and several garbage cans throughout the Faire. The parking company will also be managing the solid garbage waste transporting the filled bags to the dumpsters throughout the day during the Faire hours

We want the people here to be safe and have fun!

All agencies concerned always have total access to the Faire site.

Inspection of Premises

We agree and consent to allow law enforcement, public health and fire control officers to come upon the premises for which the permit has been granted for the purpose of inspection and enforcement of the terms and conditions of the permit issued.

We agree to correct any deficiencies in compliance as soon as possible until we get it right.

Hours of Operation

The village hours will be 10 am to 6 pm on each day the Faire is opened.

Only Participants be camping in designated area around the village as well as in the village. There will be no loud noises from either of these sites between the hours of 10 pm and 9 am on the nights the Faire is open.

Enforcement

We plan to keep a reasonable count of people and vehicles entering this gathering.

We plan on cleaning up all sites and returning them to their original or better condition than the way we found them within 72 hours after the end of the event.

Intoxicating Liquor

As per subsection 2 of Section 18 of the pertinent ordinance pertaining to mass gatherings, we will have a beer, wine, ale, and mead merchant who has his own insurance, licenses, and security. This area will be cordoned off from the village to control minors from gaining access and to keep all alcohol within the cordoned off area.

The shuttle bus will pull off Valley View onto the field at the Faire site to off and on load the people then go directly back to the road. This will keep the patrons off Valley View Rd. This is approved by the bus company.

The other 3 parking locations will not have access problems on the roads.

This plan will give us approx. 2250 places to park. From 9am-2pm there is the biggest need for parking. After 1 to 2 pm, the patrons generally come and go, which will allow for more parking.

The car access will be located off Valley View Rd. There will be no access to the Faire for the public on Hwy 213.

ODOT has requested, in the past years, that we have VMS signs (digital road signs) on each end of the Faire site on Hwy 213 stating that the event traffic and no parking on the roads. That will be honored if necessary. We will NOT allow any parking on the roads. This will be monitored by the professional parking crew. We also have 2 approved orange road signs stating event traffic ahead. We will obtain the necessary ODOT permits for the signage.

The joust show will be using a pa system during their show. The show will be held for approx. 1 hour at 12pm and 4pm each day that Faire is open. The show is 1 hour each. There will be no other PA used.

We have another group, a pirate group, who would like to shoot off period cannons twice a day for demonstration. They are loud! But, quick. They have been performing period demonstrations with us for years, but I kept forgetting to ask for County approval on this and have never shot off any cannon to date. We need your approval or not to do this. Please advise.

State Health Rule and Medical Service Compliance

The medical and emergency services will be run by the Scotts Mills Fireman's Assoc. They have all the necessary equipment, personal, and contacts. There will be 2 trained adults for first aid on site during the hours of the Faire and after hours we have 2 adults designated to be available for first aid for the participants. There is a well-marked first aid station with basic supplies located in the middle, to the west of the Faire site.

We are offering free cups of water at the first aid booth during the Faire hours. We also have 2 - 55 gallons water barrels that have 550 gallons tanks for the water barrels providing free water filled with trucked in, potable water. We have a 2500 gallon water tank. All of the tanks are cleaned professionally and filled with potable water that is trucked in for the food vendors and any other potable water needs.

The Silverton hospital is a few miles from the Faire grounds and the ambulance has clear access to the Faire area.

We will have 60 portable standard unit potties and 8 handicapped units. We have a wash basin at all the potty unit groupings on site. Approx.

10 wash basins. We have a standing agreement with the portable toilet company to bring in more potties if needed. They will be cleaned daily. There is also a wastewater basin located at the food court as well.

For garbage waste, we have 2 large dumpsters That will be emptied after each weekend and several garbage cans throughout the Faire. The parking company will also be managing the solid garbage waste. Cleaning the Faire site throughout the day of Faire hours.

Each food vendor will complete a Marion County temporary restaurant license application and submit it to the County. Each food vendor will be responsible for following all health and food safety rules. Ice will be purchased by each food vendor as needed.

The food vendors will be ready for inspection Saturday morning before we open. County Environmental Health conducts the inspections.

All communication between department heads and site safety will be done via portable radios.

There is a graveled driveway that goes around the village and is easily accessible for a fire truck and ambulance.

We will have a water truck. We have water tanks on a trailer parked just outside of the site holding over 700 gallons of water with a powerful pump for fire and dust control. That is what we used in the past successfully.

We also have access to the pump house for water at the renter's house area. Buckets of water can be made available on hand at the end of every other row around the parking areas if you deem necessary in case of fire. The grass will be mowed down to the ground and removed in hay bales.

We have tried to have a no smoking event; however, we learned that people will smoke. So, to that end, we are providing onsite containers. They can smoke out of sight and in private. We have 2 smoking areas, both in the camping area. We will have sand containers for the butts. The ground will be cleared to dirt. 2 places will be provided on the Faire site apart from each other.

We will provide the State Fire Marshall rules to all our vendors.

We have 2 artist blacksmiths who will have open flame that is contained. They are professionals and have 3 approved fire extinguishers and will have buckets of water on site. The tree limbs and leaves are higher than at the previous location. Well over 14'. We have had these same people demonstrating during previous years without incident.

The food vendors will be on bare ground and not in the trees. They are located on the far Southwest end of the Faire site.

I will provide the Silverton Fire District with a detailed map of emergency routes to and inside the Faire.
