ILLAHE HILLS STREET LIGHTING DISTRICT CERTIFICATION TO ASSESSOR OF ANNUAL LIGHTING ASSESSMENT FY 2020-21

WHEREAS, the Board of Commissioners of Marion County, Oregon, Governing Body of the Illahe Hills Street Lighting District, pursuant to the provisions of ORS 451.510 and ORS 372.180, is required each year, to determine the amount of money necessary to be raised by assessment to operate and maintain street lighting facilities within the various lighting assessment districts for the ensuing year; and this amount when determined by the Board of Commissioners shall constitute an assessment upon all the properties benefited, and to certify the same to the County Assessor each year; NOW, THEREFORE,

WE, THE BOARD OF COMMISSIONERS OF MARION COUNTY, OREGON, as Governing Body of the Illahe Hills Street Lighting District, hereby certify as follows:

- That we are the duly elected Board of Commissioners of Marion County, Oregon, acting as governing body of the Illahe Hills Street Lighting District;
- 2. That we have determined and computed the amount of money necessary to be raised by assessment to operate and maintain street lighting facilities within the Illahe Hills Street Lighting District for the ensuing year, including administrative costs and estimated delinquencies on assessments in the amount of \$8,491.55.
- 3. The attached hereto, marked Exhibit A, is a true and correct list of the properties within the Illahe Hills Street Lighting District giving the description and an ownership of each property and the proper assessment and apportionment of costs and expenses to be assessed against the respective properties for installation, operation and maintenance of street lighting facilities for the ensuing fiscal year;
