Note:

The District contracts with the City of Salem to provide sewer services to District residents. The City bills residents directly and residents make payment directly to the City. The bills also include a District administrative charge which the District records as a revenue; the District does not record revenue or expenditure for the sewer services provided by the City. Twice a year, the City turns over all past due accounts to the District and the District assumes responsibility for further collections, recording a liability to the City and a receivable from residents including a delinquent service charge of \$25 plus 20% for each account. Prior to the end of the fiscal year, the District prepares a schedule of outstanding delinquent accounts to certify to the County Assessor for subsequent collection through the property tax system.

MEETING OPENED: Commissioner Sam Brentano opened the meeting and noted the following attendance:

ATTENDANCE: Commissioner Kevin Cameron, Commissioner Sam Brentano, Commissioner Colm Willis, Scott Norris - Office of Legal Counsel, Cynthia Granatir - Office of Finance, Dennis Mansfield - Public Works, Brian May - Public Works, Matt Knudsen - Public Works, Earl Horton - ESSD Budget Committee, Michael Johnson - ESSD Advisory Committee, Doug Barrow - ESSD Advisory Committee, Glen Rader Jr. - ESSD Budget Committee, Stephanie Rosentrater -Public Works, Brian Nicholas - Public Works, Thomas Kissinger -Public Works, Kathy Rogers - Public

PUBLIC HEARING: Commissioner Brentano made a motion to open the public budget hearing.

Dennis Mansfield presented the budget. The budget includes \$75,000 in resources and \$75,000 in requirements.

No public testimony was offered.

Commissioner Brentano closed the public budget hearing.

ACTION: **MOTION:** Commissioner Willis made a motion to adopt the budget for FY2019-20. Commissioner Cameron seconded the motion. A voice vote was unanimous.

This year, the Labish Village Sewage & Drainage District is certifying \$7,283.18 in delinquent sewer fees, including a 20% penalty fee and a \$25 administrative charge on each delinquent account.

MOTION: Commissioner Cameron made a motion to approve the delinquent sewer charge certifications for the FY2019-20. Commissioner Willis seconded the motion. A voice vote was unanimous.

Dennis explained that the District is reducing the budget by \$1,131 to align Net Working Capital to Actual. The District had to increase Material & Services by \$1,000 for administration of the district and is decreasing Contingency by \$2,131.

MOTION: Commissioner Willis made a motion to adopt the first supplemental budget for FY2018-19. Commissioner Cameron

seconded the motion. A voice vote was unanimous.

MOTION: Commissioner Cameron made a motion to approve the minutes of the February 5, 2019 Governing Body meeting. Commissioner Willis seconded the motion. A voice vote was unanimous.

- PUBLIC COMMENT: Michael Johnson commented that over half of the delinquent sewer certification list had Latino names and was wondering if maybe there was a language barrier. Dennis will check in with the City of Salem to see how they send out notices and bills. Commissioner Cameron also suggested staff check to see if these same customers are delinquent on property tax payments.
- NEXT MEETING: The next Governing Body Meeting is scheduled for Wednesday, January 22, 2020 at 3:00 PM, in the Silverton Conference Room, Marion County Courthouse Square, 555 Court St. NE, Salem, Oregon.
