### **MARION COUNTY REENTRY INITIATIVE** (MCRI) Helps Individuals Remain Crime Free Through:

## Employment Solutions

MCRI works with more than 200 employers to support them in extending job opportunities to qualified reentry clients.

## Transition Solutions

MCRI supports multiple programs that help individuals successfully transition from incarceration back into the community. This includes "reach-in" classes, facilitated by a Parole and Probation Deputy (PO), that AICs attend prior to their release from incarceration and reentry programs that incorporate community partners such as Chemeketa Community College.

## Resource Solutions

The Pathfinder Network Resource Center provides wraparound peer support services, basic needs assistance and barrier removal support, peer support classes, group activities, events, etc.

## Treatment Solutions

Local medical and treatment providers support MCRI participants through individualized care and service coordination

## Community Safety

Helping former AICs successfully integrate into the community is crime prevention. Prior to being released from prison, AICs attend one or more "reach-in" classes to learn about resources available and ready to help them when they reenter the community. In Marion County, reach-ins are working. Prior to the reach-ins, a third of individuals released were not initially reporting to their PO. Now our no-show rate is just 4%.

## Return on Investment

The cost of incarceration is far greater than the cost of providing supportive services that help individuals to be successful. Savings are realized in part by reductions in recidivism. Marion County's current recidivism rate of 12.3% is in line with statewide trends. Rebuilding lives, promoting community safety and saving taxpayers money.



## By the Numbers

*The 2022 Marion County Jail Survey provides a snapshot of the local reentry population.*

- 86.1% of Adults in Custody (AICs) are men, 12% women, 1.9% preferred not to answer, and 0.01% chose not to identify.
- 81% of AICs are parents; 79% of those have children under the age of 18.
- 59% of the children of those incarcerated at the Marion County Jail are cared for by an AIC's spouse or partner, 18% lived with grandparents; and 2% were in foster care.
- 42% self-reported having a job waiting for them upon release.
- When asked to identify the three most important reentry needs, AICs selected employment, housing, and medical care.
